#### **TAIWAN**

As you may recall, due to phytosanitary interceptions, South African pome fruit exports to Taiwan were temporarily suspended.

BAPHIQ had multiple inquiries about these phytosanitary interceptions. The Department of Agriculture, Land Reform and Rural Development (DALRRD) is currently conducting a comprehensive investigation, with production sites

undergoing a second round of evaluations. DALRRD is in the process of gathering further data on bordering orchards, host vegetation, and using aerial photographs to collect more information.

The Taiwanese have just announced the renaming of their national executive agriculture authority – an indication of a changing environment, looking at biosecurity controls.

The name and acronym of the Bureau of Animal and Plant Health Inspection and Quarantine (BAPHIQ) will be changed on 1 August 2023 to 'Animal and Plant Health Inspection Agency (APHIA), Ministry of Agriculture (MOA)'. The name change is in accordance with the 'Organisation Act of the Animal and Plant Health Inspection Agency, Ministry of Agriculture', which was announced by the President on 31 May 2023.

#### FRUIT SA SUSTAINABILITY COMMITTEE

The FPEF is participating in the newly established Fruit SA Sustainability Committee. The second meeting of the committee was held on 20 July.

The committee will be responsible for anticipating and preparing for the pressure coming mostly from Europe and other trade partners over sustainability issues that may impact the South African fresh fruit export business. This forum will be used to exchange common and commodity-specific difficulties experienced by the fresh fruit export sector – in an effort to devise solutions and reduce possible trade obstacles resulting from sustainability standards.

A draft list of potential topics was compiled for consideration by the committee during its recent session. The scope of this committee will be re-evaluated at least every six months, in order to accommodate shifting sustainability needs.

## One such example:

Presently, the European Union (EU) is debating a proposal to restrict the production for export of prohibited chemicals inside the EU. The primary obstacles presented by this suggested policy are as follows:

- A strategy that disregards the diverse agronomic demands of other areas and nations disregards the fact that agriculture, pests and diseases vary across regions and countries.
- It does not provide a fair playing field and does not narrow the gap between rich and developing nations.
- It may 'displace' the issue, since other nations with potentially worse production standards than the EU would fill the void in the supply of these prohibited compounds, which will have detrimental effects on farmers' and consumers' health, as well as on the environment.
- This will probably exacerbate the illicit trade of pesticide issue in underdeveloped nations.
- Because pesticides are not approved in Europe, it does not always make them 'more dangerous' or 'less essential'.
- It would result in a shortage of vital pest control products (on crops or for vector control).
- The majority of nations have established their own review and authorisation processes, whilst the EU's planned unilateral move strips them of this authority.
- All stakeholders had the opportunity to make their voices heard through a public consultation process, which the EU launched on 8 May and closed on 31 July 2023.

#### Eastern Cape truck booking system

On Friday 28 July, Transnet introduced the truck booking system to truckers in the Eastern Cape and follow-up sessions have been planned to work through all the questions. The plan had been to implement the system after the reefer season and PECT will go live on 27 September. However, the NCT requires system modification which is in the procurement phase and indications are that it will go live in November or December.

#### <u>Boegoebaai</u>

Transnet National Ports Authority (TNPA) has shortlisted three respondents to submit proposals for the design, funding and construction of a planned port and rail infrastructure project in the Northern Cape. The development of the new port and associated rail infrastructure, to be located in the Boegoebaai area, will improve connectivity to the Northern Cape. It will also provide the necessary logistics for manganese, green ammonia and other commodity exports in the province. It supports the opening up of the province as a mining destination.

#### Richards Bay

Following a successful Request for Information (RFI) process, the TNPA called on interested parties to respond to a Request for Proposals (RFP) to fund, design, develop, operate, maintain and transfer a Container Handling Facility for a twenty-five (25) year concession period in the Bayvue Precinct at the Port of Richards Bay. The growth capacity is estimated at 200 000 TEUs on a site footprint of approximately 675 000 square meters. The Richards Bay geographical location will reduce both logistical cost and transit time.
